**New Business: Resolution No (1)3-11 To Establish Township Board Salaries.**

**Whereas**, pursuant to MCLA 41.95(3), which provides that in a township that does not hold an annual meeting the salary for officers composing the township board shall be determined by the township board, and **Whereas**, the board of Greenwood deems it desirable to adjust the salary of the Board members to ensure that compensation for their position remains equitable and commensurate with the duties of said elective office. Therefore be it resolved that as of April 1<sup>st</sup> 2011 , the salaries of the township board members shall be as follows: Supervisor \$1,150.00 per month, Clerk \$1,200.00 per month, Treasurer \$1,200.00 per month and Trustees \$200.00 each per month. **Reports: Fire Department**, Fire Chief requested approval for a contract to recertify air-pacs every 6 years for \$125.00 each, motion to approve by Scianna/Paulus, all yea.

**Parks & Recreation** grant with Great Lakes Energy for \$2,000.00 did not pass.
