**Meeting** called to order at 7:00 PM by Supervisor Fred Lindsey.

**Old Business:** **A.** Garland tax –Assessor is going to request a 60 day extension in which to gather all information before making a decision.

**B.** Supervisor Lindsey requests that all Monthly Meeting Reports be turned in on time.

**C.** Topic of Hazardous Materials Ordinance (HazMat) pay increase was brought up for discussion by Fire Chief Kubitskey. Currently the fire department is working under the 2005 rate. Chief Kubitskey requests this ordinance be updated as follows:

- the attendance of each pumper required at the scene be increased from the current \$100.00/hour to \$200.00/hour;
- the charge for pumps which are activated be increased from \$75.00/hour to \$150.00/hour;
- water tender charge be increased from \$100.00/hour to \$200.00/hour;
- for each water tender required, the charge be increased from \$100.00/hour to \$200.00/hour;
- additional township owned fire department vehicles charges be increased to \$200/hour from the current rate of \$100.00/ hour;
- and any and all full-time and part-time fire fighters' pay be increased from the current rate of \$15.00/hour to \$30.00/hour.

Chief Kubitskey also requests that the Fire Department handle the hazmat billing instead of the Township Treasurer, as it is currently. Motion made to accept – Kubitskey/Kischnick – all yea.
