

GREENWOOD TOWNSHIP BOARD OF TRUSTEES
MINUTES OF MAY 12, 2026

The meeting was called to order at 6:00pm by Supervisor Lindsey.

Board members present: Fred Lindsey - Supervisor, Diane Bissonette - Treasurer, Amy Lake - Clerk, Brandon Watson - Trustee, Annette Chalmers - Trustee.

Bissonette motioned to accept the agenda as written, second by Chalmers. All in favor.

Watson motioned to approve the minutes of the April 14, 2026 meeting, second by Bissonette. All in favor.

Correspondence: Big Creek Township has arranged for used tire disposal at the cost of \$2.00 each for residents of Oscoda County. This will take place on June 13, 2026 from 9:00am to 2:00pm. at the transfer site on M-72 in Big Creek Twp.

Public Comment: None.

Clerk Report: Lake reported the disbursement of 32 checks in the amount of \$23,002.47 from the general fund and the disbursement of 25 checks in the amount of \$12,385.69 from the fire department fund. Bissonette motioned to pay the bills, second by Lake. All in favor.

Treasurer Report: Bissonette reported the ending fund balance for all funds at \$454,973.56. Diane received word from FEMA that only two items of reimbursement for ice storm expenditures remain open and the township should be receiving those soon.

Supervisor Report: None.

Sheriff Report: Sheriff Kann reported on activities in the county. There will be an event at Mio School on July 14, 2026 from 5:00pm to 8:00pm featuring the Sheriff Department and County Fire Departments. All are invited to attend. Bissonette thanked the Sheriff for his thoughtful response to those wishing to circulate false

information on Facebook. The Sheriff stated good and accurate information helps maintain good relations among our citizens.

Fire Department Report: Chief Moll reported five calls for service during the month of April. There were two officer meetings and two training meetings. GTFD conducted a pre-incident survey at Garland. Chief reported Engine 2 is now in service and staffed at Station 2 and Engine 1 is now in service at Station 1. The vinyl lettering is complete on FD apparatus.

Zoning Administrator Report: Zoning Administrator Ron Palmquist reported approval of five zoning permits. There were no zoning violations and no nuisance violations during the month of April.

Planning Commission Report: The Planning Commission met on April 21, 2026 and approved the resolution to adopt the Master Plan. Their next meeting will be May 19, 2026 at 6:00pm.

Zoning Board of Appeals Report: None.

Assessor Report: Report read by Lindsey.

Commissioner Report: Commissioner McCauley reported that Ruth Rd. is still closed south of Kneeland Rd as a result of the flooding. The Road Commission is still waiting on a replacement culvert.

Old Business: Lindsey is still researching information on signs to be placed on Williams Rd. concerning excessive speed.

New Business: Lindsey motioned to approve the Resolution of Adoption for the Greenwood Township Master Plan, second by Lake. Roll call taken with Lindsey, Bissonette, Lake, Watson and Chalmers voting in favor.

Lindsey motioned to allocate \$2,000 from the maintenance fund, for replacement of camera, phone and internet service at the Fire Department, Bissonette seconded. All in favor.
